manuscript requirements

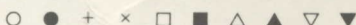
Manuscripts should be typed double-spaced on one side of the page only with wide margins and submitted in duplicate. While no maximum length of contributions is prescribed, authors are encouraged to write concisely. The title should be brief. A short abstract should accompany the manuscript on a separate sheet. Both the paper itself and the abstract should be headed by the name(s) of the author(s) and his (their) affiliation(s). In the case of co-authors, it should be clearly indicated which is to receive correspondence and proofs for correction.

Because of the international character of the journal, no rules concerning notation or abbreviation need be observed by the authors but each paper should be self-consistent as to symbols and units, which should all be properly defined. The Editors urge all authors to try to adhere to, and be guided by, *A Manual for Authors* published by the American Mathematical Society, P.O. Box 6248, Providence, RI 02904, U.S.A.

All mathematical symbols may be either handwritten or type-written but no ambiguities should arise. Greek letters and unusual symbols should be identified in the margin. Distinction should be made between capital and lower case letters; between the letter O and zero; between the letter l, the number one and prime; between k and kappa. A vector will be printed in bold face and to indicate this the letter should be underscored with a single wavy line. The numbers identifying mathematical expressions should be placed in parentheses after the equation.

Illustrations should accompany the script and will, in the printed journal, interrupt the text. The author should supply the illustrations on separate pages, but indicate the desired location in the printed text. Line drawings should include all relevant details and should be drawn in black ink on plain white drawing paper or tracing cloth. Good photoprints are acceptable but blueprints or dye-line prints cannot be used. Drawings, etc. should be about twice the final size required and lettering must be clear and "open" and sufficiently large to permit the necessary reduction of size. Illustrations are to be restricted to the minimum necessary.

The following standard symbols should be used on line drawings since they are easily available to the printers:



Photographs should be sent as glossy prints. If words or numbers are to appear on a photograph, two prints should be sent, the lettering being clearly indicated on one print only.

Figure legends should be typed on a separate sheet and placed at the end of the manuscript.

Authors are requested to supply good quality diagrams and clearly typed tables in a form suitable for *direct photographic reproduction*.

Computer programs should be given on an original print-out and will be reproduced photographically to avoid errors. Glossy prints of the original print-outs are also acceptable.

References to published literature should be quoted in the text in square brackets and grouped at the end of the paper in numerical order of appearance. Double-spacing must be used throughout.

Journal references should be arranged thus:

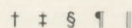

Abbreviations of journal titles should follow those given in the *World List of Scientific Periodicals* (4th edn). It is particularly requested that authors' initials, and appropriate volume and page numbers should be given in every case.

Footnotes, as distinct from literature references, should be indicated by the following symbols:



commencing anew on each page. They should *not* be included in the numbered reference system.
